*****NOTE: Weather Cancellation Policy for all CBA Sanctioned Events*****

Weather Cancellation Policy: Judges will receive 50% of a show's contracted salary due to weather cancellation. Cancellation must be announced prior to the judge departing for the contest.

For ALL CBA Sanctioned Events:

Weather Cancellation Policy: Judges will receive 50% of a show's contracted salary due to weather cancellation. Cancellation must be announced prior to the judge departing for the contest.

Expenses for out of state judges paid by the show host will include:

Round trip Air Fare

Single Room Accommodations (judges are responsible for any incidental charges including internet)

All Local Transportation including airport shuttle arrival and departure

All Meals for show day including breakfast, lunch, dinner and after show

Single Room Hotel Accommodations for In-State Judges as needed

***** mileage to and from departure city, baggage fees and airport parking is considered the responsibility of the judge and not an add-on expense*****

**Schedule 1: CBA Sanctioned One-Performance Contests: All Judges
Music/Visual/Chief Judge/T&P/Color Guard/Percussion**

One Performance show with **13 bands or less** = **\$400.00 base salary**

One Performance show with **14 bands or more** = **\$450.00 base salary**

\$16.00 per performance +14

Minimum	\$450.00	14 performances or less
	\$16.0	per performance from 14+

Announcer/ Tabulator

Minimum	\$285.00	14 performances or less
	\$12.00	per performance from 14+

Note: Exhibition and or Ratings Only performances are to be included in the performance count in the Salary Scale

****Out of State Judges** are guaranteed a base pay of \$500.00 if show does not meet the minimum band performances. **

In-State Mileage: paid @ **.40** per mile/**50 miles one way minimum** based on Google Maps / Mapquest

**Schedule 2: CBA Sanctioned Shows with Prelims/Finals: All Judges
